## TUITION FOR 2017/2018

PRE-KINDERGARTEN TUITION: \$5,330 (Monthly Payment: \$533.00 Cost Per Day: \$29.61)

GRADE KINDERGARTEN THRU GRADE EIGHT: \$4960 (Monthly Payment: \$496.00 Cost Per Day: \$27.55)

Each additional child will receive a \$250 discount from the tuition. If you intend to pay in full for a reduction of \$50.00, it must be received by June 10, 2017. Any payments after that date will not receive the deduction. Financial Aid is available through FACTS Grant & Aid Assessment. If you applied for financial aid last school year, you will need to apply again for the 2017/2018 school year. Financial aid online applications are now being accepted. The deadline is Friday, February 12, 2017. Apply online at [www.factstuitionaid.com](http://www.factstuitionaid.com) and FACTS will guide you through the process. The telephone number is 866-315-9262. The Diocesan Office makes the award decisions and will usually notify us sometime in May or June. We also wish to inform you that financial aid is also available through the school; however, in order to apply for school financial aid, you must first submit the application through FACTS.

In order to hold your child's place, the non-refundable family registration fee of \$150, per year **MUST** accompany the registration form. Every student must that plans to return in the Fall needs to complete a registration form. These forms should be returned to the school as soon as possible. **The deadline for these returns is Friday, January 27, 2017 at 4:00pm.** For your child's benefit, please respond as we may not be able to accept your child because we anticipate full classes. However, if you are still in arrears with your 2016/2017 tuition payments and have not contacted the office, you will be able to register your student but they will be unable to attend the 2017/2018 school year until the balance is paid in full.
